6. Rules need to be followed with regards to the 3 points pertaining to ISVM Awards i.e. first page of research publication need to be attached, NAAS rating of corresponding year and failing to do so no marks will be allotted for those publications.
7. Updation of Blue Book every 5 Years and Dr. D. S. Nauriyal will be assisted by Dr. G. Vijayakumar for the same.
8. A committee comprising Dr. Jyoti Dutta, Dr. Sushovan Roy and Dr. D.S. Nauriyal has submitted the guidelines for conducting elections for the EC of ISVM. The EC deliberated on the guidelines and the same after ratification by the GB shall be uploaded on the official website of ISVM. Further, the guidelines shall be included in the Blue book of ISVM.
9. The ISVM LM certificate (e-copy) needs to be generated online. Dr. Thirunavukkarasu will find necessary modalities besides development of a demo-version for ease of applying and the General Secretary has to give top priority to implement the same from 01/06/2026.
10. With regards to organization of next ISVM convention, two applications were received and the EC suggested that the 2027 ISVM convention shall be organized at Nagpur followed by SoA, Odisha in 2028. The matter to be placed in GBM.
11. With regards to the ISVM LM directory, all the members need to be contacted for correction of address. Office of the GS will co-ordinate this task with the assistance from Treasurer and Dr. Thirunavukkarasu (who will prepare the google spread-sheet) for this purpose. Every 3 years the directory would need to be updated
12. With regards to the renewal of registration of the society Dr. C.N. Galdhar, Treasurer is requested to take action at the earliest. Further, as suggested by the CA, the society will have to pay an amount of around Rs. 2.60 for filing ITR which was not been done since inception of ISVM.
13. Dr. G. Vijayakumar, Organizing Secretary appraised the EC member about the status and overview of the convention organization.
14. The EC approved that the ISVM election shall be conducted on ballot papers only. This nullifies the earlier resolution of the GB to have elections by voice vote passed during the ISVM conference held at GBPUA & T, Pantnagar in February' 2023.
15. The EC Recommended two names for the Returning officer for the Next ISVM Election:  
a. Dr. S. Prathaban and b. Dr. D.S. Nauriyal. The matter to be placed in GBM.

- b) No marks for awards/fellowship/session prize won in VIPM conferences by applicants for ISVM awards. This will be applicable for ISVM awards to be given for 2026.
- c) Any member of the EC of ISVM if found associated with the activities of VIPM, he /she shall be liable to be debarred from contesting for any portfolio of the EC.
- d) ISVM life member(s) having associate fellow/fellowship of society for VIPM will not be eligible to contest election for the EC of ISVM. This will be applicable on those who get the fellow / associate fellow after the date of approval by the GB in 2026 at MGM Resorts.
- e) The minimum marks for all the awards except Fellowship of ISVM will be 50 percent. For FISVM, it shall be 60 percent.
- f) The fund status of the proposed prof. S. K. Mishra, the founder president of ISVM shall be placed in the GB for next course of action.
- g) The EC Resolved that an amount of Approximately 1 lakh rupees be paid to the former Editorial board on production of valid bill (s).
