The Indian Society for Veterinary Medicine felicitates its Life Members in recognition of their outstanding academic contributions in the field of Veterinary Science in general and Veterinary Medicine in particular. The awards shall be presented during the inaugural or valedictory function of the National symposium and 39th Annual Convention of ISVM which is to be held at G.B. Pant College of Veterinary and Animal Science, Pantnagar from 22-24th February, 2023. **The application should reach on or before 15th December, 2022.** This year, the Society invites applications for the following awards.

For the Year 2020

1. Shri Ram Lal Agarwal Gold Medal

The applicant for the award should be of minimum 45 years of age as on 1st January, 2021. The research work done in the field of the Indigenous Veterinary Medicine during the last 3 years shall be taken into account for the year of the award.

2. Dr. D.C. Blood Gold Medal

This award is conferred on the basis of rich contribution in the area of teaching, research and other activities in the field of Veterinary Medicine. The award is open for Life Members above 32 years of age and below 45

3. Dr. G.N. Dutta Memorial Gold Medal

The award will be conferred to an applicant, who has completed 5 years as Life Member of ISVM and is of minimum 45 years of age as on 1st January, 2021. The award will be given in recognition of his/her meritorious research contributions during the past 10 years in the field of Veterinary Medicine especially in the area of the management of infectious diseases in animals.

4. Smt. P.Z. Sharma Gold Medal for Canine Medicine

The award will be given to a Life Member of ISVM in recognition of his/her outstanding contributions in the field of canine Medicine during the last 5 years in the form of quality research, clinical publications, generation of innovative ideas and development of newer techniques.

5. S.K. Mayilsamy Gounder Gold Medal for poultry Medicine

This award is open to the Life members of ISVM towards teaching, research and related activities in the field of Poultry Medicine.

6. Dr. P.K.Das Gold Medal

The award shall be given to a Life Member of ISVM in recognition of his/her outstanding contributions in the

field of Clinical Toxicology/Small Animal Medicine during the last 5 years in the form of quality research, clinical publications, generating innovative ideas and development of newer techniques.

7. Smt. Ava Roy Gold Medal

This award is open to the lady Life Members of the Society for their outstanding contribution in teaching, research and other academic activities in the field of Veterinary Medicine.

8. Award of Fellowship of Indian Society for Veterinary Medicine (FISVM)

This is the most prestigious award conferred by the Society to its Life Members in recognition to their outstanding achievements in the field of Veterinary Medicine, commendable service for the cause of Veterinary Medicine and their significant contribution to the Society. ISVM Fellowship will be awarded only to those individuals who have completed 10 Years Life Membership and are having Master's degree in Veterinary Medicine/Preventive Medicine/Clinical Medicine. The applicants must have attended minimum **TEN ISVM Conferences** after enrolment as life member. The applicant should hold the rank of Professor or equivalent, or Associate Professor or equivalent with PhD degree and 15 years of service experience. The fellowship is awarded to the person of high professional standing. The application for FISVM is required to be submitted along with comprehensive information about academic and professional achievements, distinguished published work/contributions in the field of Veterinary Medicine in 300 words. A demand draft of Rs. 2000/- in favor of "Indian Society for Veterinary Medicine" payable at Chennai, must be enclosed along with the application as required fee for consideration of application for Fellow of ISVM. The unsuccessful candidates will be refunded this amount.

9. ISVM Young Scientists Award

It is a competitive award open for Young Scientist/Teacher, who has been a Life Member of the society and is below 32 years of age as on 1st January, 2021. Entries in quadruplet typed in double space on bond paper, with unpublished full length research paper, photocopy of proof of age are required to be submitted along with a certificate from the Head of the Department verifying the place of research work and year during which the work was carried out. The

research work to be presented for this award should not find a place as abstract in the proceedings of the convention. Only the author's name will be given on the manuscript who will present the paper himself/herself. Evaluation will be based on the quality of the research work and oral presentation during the 39th ISVM Annual Convention at Pantnagar.

The candidates whose applications are rejected on technical grounds such as over age, late receipt of the application, etc. during screening will not be allowed for oral presentation during the convention.

10. Prof. Sushovan Roy Gold Medal for Best Teacher in Veterinary Medicine

This award is exclusively for a teacher for his/her outstanding contribution in the discipline of Veterinary Medicine. He /she must be a life member of the ISVM for at least 7 years and should possess Ph.D. degree in Veterinary Medicine. The applicant should be between 40 to 55 years of age and should have minimum 10 years' experience of UG teaching and 05 years of PG teaching, The minimum number of valid applications for conferring the award for a particular year is 02. Use of innovative means (like advanced teaching aids and advanced disease diagnostic and therapeutic modalities) especially in UG teaching will have more weightage. The award will be announced only after approval of the Executive Committee of ISVM. The award will be conferred in person only.

11. Sri. Babasahab Jadhav Gold Medal for Post-graduate Research in Small Ruminant Medicine

This award will be given annually to a post-graduate scholar (M.V.Sc. or Ph.D.) in the discipline of Veterinary Medicine for his / her outstanding contribution in the field of **small ruminant medicine** as post-graduate research work. The applicant should be a life member of ISVM and not more than 35 years of age on 1st January, 2021. He/ she must have completed M.V.Sc. or Ph.D. degree in Veterinary Medicine before 1st January of the year of evaluation of the award. Based on the approved thesis, the applicant should submit hard and soft copy of a write up (maximum 15 pages) on significant contribution made in the field of small ruminant medicine, along with the application in the prescribed form and processing fees. The research work must be carried out in India during last 2 years only and should be the original contribution of the applicant in the field of small ruminant medicine. The award will be conferred in person only.

12. Smt. Ramwati & Sri Devi Ram Varshney Gold Medal in Post-graduate Research in Canine Medicine

This annual award is exclusively for post- graduate scholars for the outstanding research contribution in the field of **canine medicine** made during the thesis research work. The applicant should be life member of ISVM and not be more than 35 years of age on 1st January of the year of the evaluation. He/ she must have completed M.V.Sc. or Ph.D. degree in Veterinary Medicine before 1st January, 2021. Based on the approved thesis, the applicants should submit a write up (maximum 15 pages) in hard and soft copy on significant contributions made in the field of canine medicine , along with the application in the prescribed form and processing fees. The research work must be carried out in India during the last 2 years only and it should be an original contribution of the applicant in the area of canine medicine . The award will be conferred in person only.

13. Field Veterinarian Award.

This award is open to the life members of ISVM who are working in the field and catering animal health services at grass root level. The award is conferred based on the merit of the work and his/her presentation at the 39th annual convention of ISVM at Pantnagar, Uttarakhand. The entries in quadruplet are required to be submitted along with full length clinical paper.

13. **ISVM Young Scientists Award**

Only the author's name will be given on the manuscript who will present the paper himself/herself. Evaluation will be based on the quality of the research work and oral presentation during the 39th ISVM Annual Convention at Pantnagar. The candidates whose applications are rejected on technical grounds such as over age, late receipt of the application, etc. During screening will not be allowed for oral presentation during the convention. **The last date for this award is 31.12.2022.**

14. **Field Veterinarian Award**

This award is open to the life members of ISVM who are working in the field and catering animal health services at grass root level. The award is conferred based on the merit of the work and his/her presentation at the 39th annual convention of ISVM at Pantnagar,

Uttarakhand. The entries in quadruplet are required to be submitted along with full length clinical papers.

15. **ISVM merit award for post graduate Research**

1. There shall be two ISVM merit Awards annually -one for a student pursuing Ph.D degree in the discipline of Veterinary Medicine and another for a student pursuing M.V.Sc degree in the discipline of Veterinary Medicine (Veterinary Clinical / Preventive medicine).
2. The value of award for a Ph.D., and M.V.Sc student shall be Rs.5000/- and Rs.4000/- respectively to be given once during the degree programme.

The applications for the award should be duly recommended by the guide and forwarded by the Head of the Department concerned.

3. The applications shall be evaluated by the committee nominated by the President / General Secretary.
4. The awardee should give an undertaking through the guide about submission of his /her thesis in stipulated time.
5. The award shall be presented at the ISVM convention in the form of cash prize (in the form of DD/ Bankers cheque) and a certificate.
6. The awardee must submit the findings of his/her research work to the ISVM office for records and further dissemination, if felt necessary. If the awardee is not able to submit his/her M.V.Sc /Ph.D thesis in the stipulated time, the awardee has to refund the award to the ISVM.
7. A student can get the ISVM Merit Award only once.
8. ISVM shall have the authority to stop /discontinue / withdraw/not award the ISVM Merit Award in any year without assigning any reason thereof.

AWARD APPLICATION PROCEDURE

The eligible members are requested to submit application in **quadruplet** for the awards/fellowship with detailed the following sub-heads giving specific to the award.

- International, National and ISVM awards received
- Total number of research and clinical publications (not popular articles) in peer reviewed Indian and Foreign Journals
- List of published reviews in journals and international proceedings/books (Enclose the list)

- Number of research and clinical publications relevant for the specific award (enclose the list)
- Contribution to the advancement of Veterinary Medicine
- List of papers presented in the international Conferences and Symposia.

GENERAL RULES APPLICABLE TO ALL AWARDS

1. Only members of ISVM after **seven years** (except ISVM Young Scientist Award, Sri Babasaheb Jadhav Gold Medal for Post Graduate Research in Small Ruminant Medicine, ISVM merit award for post graduate Research, Smt. Ramwati & Sri Devi Ram Varshney Gold Medal for Post Graduate Research in Canine Medicine & Field Veterinarian Award) of enrolment are eligible to apply for any of the awards.
2. For all ISVM awards (except ISVM Young Scientist Award, Sri Babasaheb Jadhav Gold Medal for Post Graduate Research in Small Ruminant Medicine, ISVM merit award for post graduate Research, Smt. Ramwati & Sri Devi Ram Varshney Gold Medal for Post Graduate Research in Canine Medicine & Field Veterinarian Award), the applicants must have attended minimum **FIVE ISVM Conferences** after enrolment as life member
3. Incumbent executive Committee members of ISVM are not eligible for consideration of any of these awards, the exception being fellow of ISVM
4. Recipient of ISVM award during last two years is not eligible to apply for any of the ISVM awards eg. any person getting the award in 2019 shall be eligible to apply in 2022 and so on.
5. Persons applying for more than one award should indicate the preference order.
6. The minimum quorum for all the awards except FISVM is two.
7. The General Secretary, in consultation with the President, may reject application for any award for want of required quorum or incomplete application.
8. The President and General Secretary reserve all rights to accept/reject any application without assigning any reason for the same.
9. All the applicants will be required to submit half page writeup for the citation along with their original applications.

10. A sum of Rs. 250/- will be payable to the ISVM by the applicants as demand draft in favour of Indian Society for Veterinary Medicine payable at Chennai for each award applied as the processing fee except for the nomination of ISVM lifetime achievement award.
11. The award may not be given for the year, if an applicant does not get the qualifying minimum score.
12. The content of the application with respect to credentials/ contributions should be verified by the respective Heads of the Department/Institution.
