**B. Eligibility criteria:**

- I. The Life Members of ISVM possessing Master's degree in Veterinary Medicine/Veterinary Clinical Medicine/Veterinary Preventive Medicine are eligible to contest the election for any post of Executive Committee of ISVM.
- II. The contestants for the post of General Secretary and Treasurer should be from the same college or institute.
- III. The contestants for the post of Editor, Associate Editor and Assistant Editor should be from the same college or institute.
- IV. To contest the election for the post of President, Vice-President, General Secretary and Editor, the candidate should have a minimum standing of 10 years as Life Member of ISVM.
- V. The candidates contesting for the post of President, Vice-President, General Secretary and Editor should either be currently in active service or would have retired from an academic institution or research institute or extension organization.
- VI. Any Life Member of ISVM, who has received Associate Fellowship/Fellowship from the VIPM Society after 17/02/2026, is not eligible to contest election for any post of EC of ISVM.



- III. Nomination forms which do not contain required information as asked for in the prescribed form, and/or supporting documentary proof thereof, shall be considered incomplete and rejected.
- IV. Last date for the receipt of the nomination at the office of Returning Officer is 13/07/2026. The candidate(s), whose nomination form is received after the last date, will be considered ineligible to contest the election.
- V. The withdrawal of nomination shall have to be done by communicating to the Returning Officer by **speed post / registered post only.**
